- Invoice
- Packing List.
- Bill of Lading (BOL). *(Preferably Express Bill of Lading).*
- Certificate of origin **(only for material originated in EU)**: EUR1 or an origin declaration for authorized exporter suppliers.
- **When applicable** (Example: chemicals): MSDS and Certificate of Analysis (COA).
- Machinery & Equipment Serial Numbers must be written in all documents.
- All Documents **MUST HAVE** the name of the Project and Task.
- Technical Data Sheet.
- Photos of the cargo.

- In Mexico, it is required that every wooden packaging is previously fumigated and has a certification or stamp as a proof. You can refer to the NOM-144 SEMARNAT. (*ISPM 15*).
